FOSTER/ADOPTIVE FAMILY RECRUITING AND ADOPTION GUIDANCE: ACROSS MONTANA, NEARLY 4,000 CHILDREN HAVE BEEN REMOVED FROM THEIR BIOLOGICAL FAMILIES DUE TO SEVERE ABUSE OR NEGLECT. WITH LESS THAN HALF THE FAMILIES REQUIRED TO CARE FOR THESE CHILDREN, THE NEED FOR MORE FOSTER/ADOPTIVE FAMILIES IS CRITICAL. CHILD BRIDGE RECRUITS FAMILIES FROM THE MONTANA FAITH COMMUNITY TO ADOPT AND/OR FOSTER ABUSED AND NEGLECTED CHILDREN RESIDING IN MONTANA'S CHILD WELFARE SYSTEM. IN 2017, 230 CHILDREN WERE PLACED WITH CHILD BRIDGE RECRUITED AND/OR SUPPORTED FAMILIES, ADDING TO OUR HISTORICAL SUCCESS OF 519 CHILDREN PLACED AND 67 CHILDREN ADOPTED SINCE 2011. WELL OVER 15,000 PEOPLE HEARD THE MESSAGE ABOUT THE NEED FOR FAMILIES TO FOSTER AND/OR ADOPT IN 2017.

AS A VITAL MEANS OF COMING ALONGSIDE THE FAMILIES CARING FOR CHILD VICTIMS OF ABUSE, CHILD BRIDGE HOSTS MONTHLY FOSTER/ADOPTIVE FAMILY RESOURCE GROUPS. WELL-SUPPORTED AND EDUCATED FOSTER FAMILIES PROVIDE MORE STABLE ENVIRONMENTS, MINIMIZING CHANCES FOR RELOCATION OF THE CHILD. THE GROUPS ARE A VITAL PART OF ESTABLISHING FAMILY STABILITY WHICH DIRECTLY RELATES TO A CHILD'S ABILITY TO HEAL FROM PAST ABUSES. CHILD BRIDGE SERVED 4,745 INSTANCES OF ADULTS AND CHILDREN IN 2017.

MANY TIMES WHEN A CHILD IS REMOVED, THEY ARRIVE AT THEIR FOSTER HOME WITH NOTHING.
